

TERMS AND CONDITIONS

1. Registration

The registration must be completed online through registration form at www.exoticpolecamp.com website. By registering the participants confirm that they are aware of these general terms and conditions and accept them.

The minimum age is 18.

2. Payments

Within 2 business days following the registration, the participants will receive payment instructions via email. The payment must be made by bank transfer to the account identified in the email within 2 weeks. Once the bank transfer is successfully completed, each participant will receive a confirmation of payment received by e-mail.

The price of participation is as follows:

455 EUR / 11600 CZK – registration and payment until 28th February 2018

495 EUR / 12600 CZK – registration and payment after 28th February 2018

The price includes:

- 12 workshops (90 minutes, maximum 2 participants per 1 pole)
- Social events (meet and greet picnic, sightseeing tour or any other mid-week activity, farewell party with 2 drinks included)
- Gift bag from sponsors

The price does not include:

- Travel costs
- Accommodation
- Meal costs
- Insurance

3. Cancellations

If the participant is unable to attend, she or he has the right to name a substitute participant up to 7 days before the camp starts. Any substitute must be approved by camp organisers and any such substitute must accept all terms and conditions of the event.

In case of the cancellation with no substitution the following cancellation fees apply:

Cancellation up to 45 days before start	50 %
Cancellation 44 or fewer days before start	100 %

All cancellations and substitutions must be made in writing to info@exoticpolecamp.com.

4. Liability and insurance

Participation in the camp is entirely at participant's own risk. The participants understand that it is their responsibility to consult with a physician prior to and regarding the participation in the workshops. The participants acknowledge, that they have no medical condition that would prevent their participation in the workshops. No liability will be accepted in the event of injuries or accidents. Also, organisers shall have no liability for damage, theft or loss of personal property. The participants are recommended to arrange their personal travel and health insurance.

5. Changes / Cancellation of the event

The organizers reserve the right to make changes to the published schedule of training (but not the overall content) or instructors if one or more of the advertised instructors is unable to attend. In such case, the participants will have no claim against the camp organizers in respect of such changes, and they will not be entitled to cancel.

In case of the event cancellation, the sum already paid will be refunded to the participants within 4 weeks.

6. Media and footage from the event

Participants of the camp will be photographed and/or filmed. These recordings can be used for promotional purposes on www.exoticpolecamp.com website, in flyers and other printed materials, newspaper reports and also on Facebook and other social media-channels. Any media or footage from the event remains the property of the organisers. By registering the participants expressly give their consent to publication without compensation of any photos or film recordings made of them.

7. Personal data protection

Participants give their consent to the collection, processing and use of the personal data required to complete the business transaction with the organizers. Participants personal information may be further used for marketing, advertising or product/service offering purposes by organizers. The organizers will not sell, trade or transfer such personal information to third parties. Participants can revoke this consent at any time. In this case the data will be deleted once the business transaction has been completely processed.
